Speech by Mr Haris Loizides, President of the Cyprus Hotel Association

Dear Mr President, Distinguished guests, Ladies and Gentlemen,

With our membership in HOTREC, we look forward to gaining experience and further improving our tourist product, as well as strengthening our voice within the EU. We, as the Cyprus Hotel Association, with its more than 75 years' history, stand ready to contribute constructively and creatively via collaborative work, towards the implementation of HOTREC's main vision.

Once again I welcome you all, and I wish everyone in the General Assembly success. In closing, I call upon all spearheading leaders of our industry, trade professionals and general entrepreneurs from all over Europe, to continue the hard work so that our business connection continues to thrive.
